

Malthoid[®] Damp Proof Course

Application

Malthoid[®] Damp Proof Course (DPC) is a 2 ply felt material impregnated with bitumen and coated with fine sand. It is recommended for use as a moisture barrier between building elements. It can be used as a vapour barrier for structural elements in contact or close proximity with the ground when installed as per the instructions below.

Suitable for use as a;

- Moisture barrier under bottom plates
- Moisture barrier between timber jack studs and timber piles
- Moisture barrier between any wooden surface and concrete, masonry or aluminium

Features and Benefits

- Flexible for quick and easy installation
- Fine sand applied to both surfaces to reduce sticking

Malthoid[®] Damp Proof-Course satisfies the requirements of NZBC E2/AS1 Table 23, NZS 3604 2.3.3[b].

NZBC Clause B2: Durability

Malthoid[®] will meet the durability requirements of NZBC B2/AS1 Table 1- Damp Proof Course, provided the product is used and installed correctly. Malthoid[®] must not be used in situations where it will be exposed long-term to sunlight, or prolonged contact with chemicals and solvents.

Limitations

To meet the above Malthoid® must be:

- Installed as specified in this data sheet
- Kept dry at all times and not allowed to remain wet during construction or in service
- Must not be used for head flashings as the bottom edge is normally exposed
- Must not be used around flues and chimneys as a flashing or a damp proof course

Installation

General

- Ensure all surfaces are flat and smooth. Remove all loose debris, such as stones, that could puncture the membrane.
- Roll out and cut Malthoid[®] along the face of the timber using a sharp knife.
- Malthoid[®] can be temporarily held in place on timber framing using hot dip galvanised clouts or staples before framing is stood up. Ensure Malthoid[®] extends at least 6mm beyond each face of the timber.
- When used under timber plates fixed over concrete floor slabs and foundation walls small slits should be made before Malthoid® is pushed over the bolts or fixings.

Prenailed Frames

• When intended for use beneath bottom plates of prenailed wall frames erected on concrete floor slabs, it is recommended that the pre-nailer be encouraged to fix it in place to the underside of the bottom plate before the frames leave the factory.
